Please follow this guide to ensure prompt delivery of your schedule II controlled substances. Please note: we must have a valid 222 order form before any order may be shipped. We must have on file a current copy of your DEA Registration with Schedule II endorsement. All Schedule II orders require DEA Form 222, pre-printed with your address and serial number. The order form must be signed and dated by a person authorized to sign a registration application or a person holding Power of Attorney to Sign an Official Order Form. **Intrathecal orders require an additional patient specific order corresponding to the items listed on the 222 Form.**
